

## **CONSTITUTION**

### **Objectives:**

- ❖ To increase computer skills among the members.
- ❖ To enable members acquire teamwork skills.

- ❖ To promote creativity among the club members.

### **Rules & Regulations:**

- a. All SUST*ian* (including college students under SUST) can be members of this club.
- b. Any political executive members are not allowed in this club.
- c. Membership will be cancelled by the consent of at least two-third of the executive members.
- d. The 'president', the 'General Secretary' & the 'Director of training wing' of every executive committee will be considered as the life time member of the club.
- e. If a member [except life time member] is absent in the activities of the club for six months, his membership will be automatically cancelled.
- f. No one can hold the same post twice except the post of executive members.
- g. Membership will be cancelled automatically as soon as the member finishes his graduation.
- h. The duration of every executive committee will be one year and should be changed at the time of the anniversary.
- i. Rules and regulations should be moderated with the consent of at least two-third of the executive members.

j. If any decision initiated by executive members doesn't reach any conclusion, then it will be referred to the advisory committee.

#### **Treasure:**

- a) The source of finance will be entry fee, monthly subscription of the club members, and sponsorship.
- b) Bank account of the club will be conducted by the joint signature of the president and general secretary and treasurer.
- (c) Two persons among the above three can withdraw the money by joint signature.
- (d) Monthly financial details should be published.

#### **Executive Committee:**

- a) Executive committee will be elected or selected. In case of selection at least two-third of the general members of the club need to be agreed.

### **Responsibility of the executive members:**

#### 1) President:

# 9) Director of training wing:

S/He will maintain all kind of training related activities.

#### 10) Members:

They will assist President, General Secretary and in performing various activities of the club.
